Re: Fair Employment Practices Statement

Dear Colleagues:

Our Company is committed to equal employment opportunity and affirmative action in compliance with all federal, state, and local laws and regulations regarding fair employment practices. In accordance with these laws and regulations, and consistent with our Core Values, each person has the right to be treated fairly and work in an environment free from discrimination and harassment, including sexual harassment. At SEMCO, we take these rights very seriously.

Accordingly, the **AltaGas Respectful Workplace Policy** prohibits acts of discrimination, harassment, including sexual harassment, bullying, cyber bullying, and workplace violence, against employees and applicants. The Company also prohibits retaliation against any individual who, in good faith, reports discrimination, harassment, bullying, cyber bullying, or workplace violence, or who participates in any investigation or proceedings related to such reports. To support our Code of Business Ethics and Core Values, we must build an environment of openness and mutual respect, in which we can be our best and grow in our jobs. We will not tolerate any form of discrimination, harassment, bullying, cyber bullying, workplace violence, disparaging or offensive remarks or actions, unwelcome sexual advances, or requests for sexual favors, and any other such unlawful conduct – all of which run counter to our Core Values and principles at SEMCO. Instead, we embrace differences with our focus on diversity and inclusion, working in partnership with each other.
